

SAFEWAY GAME ON PERKS REWARDS PROGRAM OFFICIAL RULES AND TERMS AND CONDITIONS

- PROMOTION PERIOD: The Safeway Game On Perks Rewards Program (the "Rewards Promotion") including the Sweepstakes ("Random Drawing Sweepstakes") begins 12:00 AM (midnight) Mountain Time ("MT") on August 23, 2023 and ends 11:59 PM MT on January 7, 2024 (the "Promotion Period"). Points are only available from 12:00 AM MT on August 23, 2023 until 11:59 PM MT on December 26, 2023 ("Purchase Period"). Points must be redeemed by 11:59 PM MT on January 7, 2024.
- 2. **ELIGIBILITY**: Open to legal U.S. residents, including employees of Albertsons Companies, Inc. ("Sponsor") employed in Sponsor's Northern California Division who shop at stores listed in Exhibit A and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each, who reside in northern California, northern Nevada or Hawaii and shop at participating stores listed in Exhibit A below ("eligibility area"), eighteen (18) years of age and older at time of participation ("Participant"). There is no limit to the number of Points you can accumulate throughout the Purchase Period. Participants will then visit their Safeway for U® account at safeway.com/gameon, during the Promotion Period to redeem their accumulated Points for rewards merchandise ("Merchandise"). - 2024 Tickets Prize (10 total): Two (2) tickets, one (1) for winner and one (1) for guest to attend a San Francisco 49ers game at Levi's® Stadium on a date mutually determined between Sponsor and Team during the 2024 football season; one (1) parking pass; food and non-alcoholic beverages in the Levi's® Club at Levi's® Stadium; and two (2) 49ers Museum passes for the day of the game (collectively, "Game"). Guests of 2024 Tickets Prize winners (or winner on behalf of minor guest who is their child/charge) will be required to read and complete a waiver on premises on the day of the Game in order to attend (ARV: \$350 each).
- <u>Groceries for a Year Prize (5 total)</u>: \$5,800, awarded in the form of fifty-eight (58) \$100 Safeway gift cards (ARV: \$5,800).
- Signed Merchandise Prize (5 total): One (1) sponsor-specified merchandise item autographed by a San Francisco 49ers player or alumni (ARV: \$10).
