

**THE 2026 SHOP AND SCORE PROMOTION**  
**OFFICIAL RULES**  
NO PURCHASE NECESSARY

1. **PROMOTION PERIOD:** The 2026 Shop and Score Promotion (“**Promotion**”) begins 12:00 AM (midnight) Mountain Time (“**MT**”) on April 1, 2026 and ends 11:59 PM MT on June 2, 2026 (the “**Promotion Period**”). Points are only available from 12:00 AM MT on April 1, 2026 until 11:59 PM MT on May 26, 2026 (“**Purchase Period**”). Points must be redeemed by 11:59 PM MT on June 2, 2026. The Promotion consists of a Rewards Program (“**Rewards Program**”) and a Sweepstakes (“**Sweepstakes**”). The Sweepstakes consists of a series of random drawings which includes seven (7) weekly entry periods (each, a “**Weekly Entry Period**” or “**Entry Period**” and “**Weekly Entry Period Drawings**”), two (2) First Prize entry periods (“**First Prize Drawings**”) and one (1) Grand Prize Finalists Event entry period (“**Grand Prize Finalists Event Drawing**”), as defined in the chart below in Rule #4.
2. **ELIGIBILITY:** Open to legal U.S. residents, residing in Oregon or Washington, who are eighteen (18) years of age and older at time of participation and shop at stores listed in Exhibit A (“**Entrant**”). To participate in the Finalists Event, you must be twenty-one (21) years of age or older at time of participation. Employees of Albertsons Companies, Inc. (“**Sponsor**”), Don Jagoda Associates, Inc. Points earned in each transaction will equate to the number of Participating Products purchased, while supplies of Participating Products last. There is no limit to the number of Points you can accumulate throughout the Purchase Period. Entrants will then visit their Albertsons for U<sup>®</sup> ([albertsons.com/shopandscore](https://albertsons.com/shopandscore)) or Safeway for U<sup>®</sup> ([safeway.com/shopandscore](https://safeway.com/shopandscore)) account (“**Account**”) during the Promotion Period to redeem their accumulated Points for rewards merchandise (collectively “**Merchandise**”) or Sweepstakes entries (collectively, “**Online Entries**” or “**Entries**” and singularly, “**Online Entry**” or “**Entry**”). All Points must be redeemed by the end of the Promotion Period. Entry Period Mailed Entries and First Prize Mailed Entries Mailed Entries will be collectively referred to herein as, "**Mailed Entries**" or "**Entries**" and singularly, "**Mailed Entry**" or "**Entry**". Limit one (1) Mailed Entry per envelope. No mechanically reproduced Mailed Entries permitted. Each Mailed Entry earns five (5) Points, which equates to one (1) Entry into the applicable Entry Period drawing or one (1) Entry into the applicable First Prize drawing (based on which drawing is indicated). Trip may not be combined with any other offer and travel may not qualify for frequent flyer miles. Winner and his/her respective travel companion must travel together on the same itinerary and at the same time, and must possess valid travel documents (i.e., REAL ID-compliant driver’s license or REAL ID-compliant non-driver identification, passport or passport card) in order to travel. Neither the Sponsor nor Released Parties assume any responsibility for incorrect or inaccurate capture of Entrant information including, but not limited to, technical malfunctions, human or technical error, printing errors, lost/delayed/garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software, Points/Entries that are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with these Official Rules or any combination thereof. In the event this Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Sponsor reserves the right to cancel, terminate or suspend the Promotion. In such event of early termination, Sponsor shall give notice at least three (3) days prior to the date that such termination becomes effective via email notification, during which time Entrants may still accrue and redeem Points for Merchandise or Entries and all Entries will be included in the drawings, as applicable. All Points must be redeemed for Merchandise or Entries prior to the effective date of termination. Sponsor is not responsible for any typographical or other error in the printing of the Promotion materials or the offering or announcement of the prizes.
